<u>F/C</u> [FD/SS/KD] 6(b-1) Presentation by PFM Consultants – 2nd Quarter of Fiscal Year 2018/2019 – Accept & File Report

Mr. Richard Babbe of PFM Consultants provided a presentation on AVEK's Investment Portfolio Review for the quarter ending December 31, 2018. He stated that our present strategy has served us well and now there is a different economic environment. Highlights included a market update; strategy and portfolio review; distributions, transactions, and holdings.

ORDERED: On motion by **Donato**, second by **Barnes**, to accept and file the PFM 2nd Quarter Report for Fiscal Year 2018/2019 as presented. **Voting: 7-0; Carried**.

Revenue and Expense Report for 2nd Quarter of Fiscal Year 2018/2019 – Accept & File Report. The board and staff reviewed the Quarterly Revenue and Expense Report for the quarter ending December 31, 2018. Year-to-Date actual compared to the 2018/2019 budget was compared in the categories of operating revenues, operating expenses, non-operating revenues, and non-operating expenses. Total revenues for the quarter were reported to be 59% of the annual budget, while total expenses were reported to be 46% of the annual budget.

Accept and file the Check Register List from January 17, 2019 through February 6, 2019 6(b-3)

Accept and file Treasurer's Report for month ending January 31, 2019

ORDERED: On motion by Donato, second by Barnes, to accept and file the Treasurer's Report for the month ending January 31, 2019, as presented. Voting: 7-0; Carried.

Purchase Order over \$25,000.00: Rebuild two QHWTP Moss Screens -- Farm Pump & Irrigation -- \$76,431.02. GM Chisam stated that the moss screens in question are 7 years old and are in need of repair in preparation for the coming summer months. Cost is \$76,431.02 for both to be rebuilt.

ORDERED: On motion by Donato, second by Dyas, to approve Purchase Order No. 19-0036 in the amount of \$76,431.02 payable to Farm Pump and Irrigation for the rebuilding of two QHWTP moss screens as presented and recommended. Voting: 7-0; Carried.

PLANNING

6(c-1) Status/Update > Meeting of 1/29/19

[KD/SS/RP)] Committee Chair Dyas stated that there was no request for board action as a result of the meeting of January 29, 2019. He deferred to GM Chisam to report another item requested by the AVSWCA that corresponds with this committee.

AVSWCA Sponsorship of the 2019 Home Show/Smart Water Expo 3/22/19 to 3/24/19. GM Chisam stated that the 6(c-2)previous year the Home Show was combined with the Expo event. The AVSWCA proposed a combined \$10k sponsorship. When AVEK participated in the EXPO, our share was in excess of \$25k. This is a budgeted item. Staff recommends participation with the AVSWCA for \$8,570. Director Donato expressed opposition with AVEK's share of the fee. It was stated that the amount was based on the Agency's Table A allocation. He asked that the contributions be reevaluated in the future.

ORDERED: On motion by Barnes, second by Parris, to authorize a contribution in the amount of \$8,570 to the Antelope Valley State Water Contractors Association (AVSWCA) for the 2019 SMART Water Expo in conjunction with the March 22-24, 2019 Home Show at the AV Fairgrounds as presented and recommended. Voting: 7-0; Carried.

ITEM 7. **GENERAL MANAGER'S REPORT ON WATER SUPPLY, PROJECTS, AND PROGRAMS:**

GM Chisam stated that Governor Gavin Newsom recently gave a "state of the State address" wherein he did not support the proposed twin tunnels, but a single tunnel. DWR will reanalyze and this will likely cause a 2-year delay. President Sorsabal also indicated that this subject was discussed at the recent CFEE Conference. A water tax is also on the table for discussion. Other legislative updates and key takeaways were also provided including new appointments.

State weather indicates that the drought conditions are improving. Total precipitation since January 1, 2019 is 19.4." Current storage in San Luis Reservoir is 1.82 million AF, which is 89% of total capacity. State Water Project draft of fishery regulations and biological opinions were reviewed. Initial Table A allocation of 10% was increased to 15%. Additional increases are anticipated in the coming weeks and are anticipated to be 35% to 50%. Statewide snowpack was reported to be 129% of average.

Water deliveries for conventional treatment was at 9.4 MGD, with geopurification deliveries at 3.6 MGD. Total water deliveries were 13 MGD (40 AFD). Water Banking (SWP recharge and storage) for the Westside banking was 20 AFD and Eastside banking facility totaled 4.5 AFD for a total of 24.5 AFD for SWP recharge and storage. AVEK water quality THM's remain well below our internal goal of 64 µg/L. Initial quarterly testing for 123-TCP for wells was completed – all were non-detect (ND) and as such, this is only required every 3 years. Quarterly compliance sampling was taken on 2/21/19. Recently promoted Laboratory Manager Jordan Wray was approved by ELAP (Environmental Laboratory Accreditation Program) as acting laboratory director. Upcoming events (conferences and meetings for the AV Board of Trade Business Outlook Conference, AV Watermaster, Urban Water Institute and CFEE Roundtable) were discussed along with the general manager's upcoming schedule.

7(a-1) Annual Water Supply Plan as of 2/12/19. GM Chisam highlighted and reviewed 2019 SWP allocation scenarios for AVEK supply vs. demand. The board thanked GM Chisam for this presentation.
